The scheme shall come into force from the date of issue of this notification.



**SCHEME FOR FUNERAL ASSISTANCE IN CASE OF DEATH OF REGISTERED CONSTRUCTION WORKER:**

under the rule 282 (Other Welfare Measures) of The Tripura State Building and Other Construction Workers(RE & CS) Rules 2001, the scheme for funeral Assistance in case of death of registered construction workers is hereby made as follows:

1. One time grant of Rs.10,000/- ( Rupees ten thousand ) is provided to the nominee or spouse or dependant of the deceased registered beneficiary to meet the expenses of funeral ceremony.
2. The amount shall be sanctioned only if the following conditions are fulfilled, namely:
  - The nominee, spouse or dependant of the deceased registered beneficiary is eligible to get the benefit.
  - The application should be submitted within 30 days from the date of death of the registered construction worker or the application for the same may be submitted while claiming for the death benefit by the nominee.
  - The registered construction workers shall have no dues payable to the Board.
  - The amount of benefit payable by the BOARD shall be paid through DBT mode.
3. **Supporting Documents:**
  - Original BOCW registration card
  - Prescribed Application Form
  - Bank Account Details of nominee
  - Death certificate from a appropriate authority or death report from the recognized registered Medical Officer.
  - Photo copy of ration card.
  - A declaration/No objection should be submitted by all the nominees/survivors of the deceased registered construction worker in favour of the applicant.
  - Any photo ID proof of Nominee.
  - Ration card
  - Any other documents as on when required.
4. **How to apply:** The registered beneficiary will apply electronically. The concerned area Labour Inspector will process and verify the application and Labour Officer will review and approved the application.
