



## Annexure-VIII

### FINANCIAL ASSISTANCE IN MEDICAL TREATMENT

1. Under this scheme all registered active BOC Workers shall be covered under Ayushman Bharat Yojana (ABY) and beneficiary and members of his family will be provided financial coverage upto 5 lakh.
2. The eligibility for enrollment of family shall be as defined under AB-PMJAY.
3. This would be tied up with State Health Agency through TBOCWWB for implementation of AB-PMJAY for Building and other construction workers.
4. Tripura Building and Other Construction Workers Welfare Board will be borne the expenditure for treatment under this scheme with a ceiling limit up to 5 lakhs or the actual expenditure, whichever is less
5. Facilitate, monitor and evaluate the implementation of the scheme as per guidelines of AB-PMJAY, issued from time to time by the Central Government and such additional guidelines as the State Government itself shall adopt from time to time in relation to the scheme.
6. All registered beneficiary will be provided AB-PMJAY benefits as per the scheme's package list with standardized codes for procedure packages.
7. The operational guideline for implementation of the scheme shall be notified in consultation with SHA by signing MoU.
8. **How to apply:** The registered beneficiary will apply in prescribed form through electronically. The concerned Labour Inspector will process and verify the application and Labour Officer will review and approved the application.
