

NOTIFICATION

As per provision of Rule 275 (Payment of death benefit) of Tripura Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Rules, 2001, the Scheme for **Financial Assistance to the registered beneficiary in case of Death** was formulated and approved by the Tripura Building and Other Construction Workers Welfare Board in its 30th Board meeting held on 1st July 2022. Further the same has been approved by the Government in Labour Department vide U.O. No.162/Min/SCW/ARDD/Labour, dated 12th August, 2022. The copy of the Detailed Scheme is enclosed in **Annexure-II**.

The scheme shall come into force from the date of issue of this notification.



FINANCIAL ASSISTANCE TO A REGISTERED BENEFICIARY IN CASE OF DEATH:

Under the rule 275 of The Tripura State Building and Other Construction Workers (RE & CS) Rules 2001, the scheme for Financial Assistance to a Registered Beneficiary in case of death is hereby made as follows:

To provide financial assistance to the nominee or spouse or dependent of the deceased registered beneficiary.

1. The amount of financial assistance that will be sanctioned to the nominee/ legal heir or dependant of a beneficiary by the Board is as under:

- i). One time grant of Rs. 2, 00,000/-(Rupees Two Lakh) in case of natural death.
- ii). One time grant of Rs. 4, 00,000/-(Rupees Four Lakh) if the death is due to accident during the course of employment.

2. The amount shall be sanctioned only if the following conditions are fulfilled, namely:

- The nominee, spouse or dependant of the deceased registered beneficiary is eligible to get the benefit.
- In case of death due to an accident during the course of employment the first information report from the nearest police station to be produced to the Board.
- The death certificate of the registered beneficiary duly issued by the Registrar birth and death shall be uploaded on the portal.
- The registered construction workers shall have no dues payable to the Board.
- Application shall be submitted within 1 year of death.
- If any registered beneficiary is covered under Group Life Insurance scheme, is taken by the Board, death benefit as envisaged in this scheme will not apply.

3. Supporting Documents:

- Original BOCW registration card
- Online prescribed application Form
- Bank account details of nominee
- Death certificate from an appropriate authority or death report from the recognized registered Medical Officer.
- Photo copy of ration card.
- A declaration/No objection should be submitted by all the nominees/survivors of the deceased registered construction worker in favour of the applicant.
- Any photo ID proof of Nominee.
- Ration card
- Any other documents as and when required.

4. How to apply: The registered beneficiary will apply in prescribed form through electronically. The concerned Labour Inspector will process and verify the application and Labour Officer will review and approved the application.
